What follows is a short summary of the decisions and actions of the Session, at the December 15, 2020 Session Meeting. The minutes of the meeting will contain a more complete record.

The Session of First Presbyterian Church met, virtually via Zoom at 6:00 pm on Tuesday, December 15th.

The meeting was opened by Clerk of Session Dave Dreydoppel with prayer and devotion.

In the absence of Moderator Jim Aldrich, it was **moved**, **seconded** and **passed** to elect Ruling Elder Stephanie Rozell as Acting Moderator, until Moderator Aldrich can resume his duties.

It was **moved**, **seconded** and **passed** to approve the agenda as presented.

- Vital Statistics from November 18, 2020 to December 15, 2020, as well as Minutes from the November 17, 2020 Stated Session Meeting and the December 5, 2020 Called Session Meeting, were received. It was **moved**, **seconded** and **passed** to approve them as presented.
- Correspondence was received from Pastor Search Committee Members Sheila Williams and Michelle VanHatten tendering their resignations from the committee.
- Correspondence was received from Ruling Elder Mark Lawson, tendering his resignation from Session. It was **moved**, **seconded** and **passed** to accept his resignation, with regret.
- Correspondence was received from the Presbytery of the Pacific Northwest about registration for the January Presbytery Meeting. Information has also been received that there will be a ZOOM option for attendance. It was **moved**, **seconded** and **passed** to elect Dave Dreydoppel as the Commissioner from First Presbyterian Church.
- Consent Calendar items were **passed** as proposed. The Consent Calendar items included: Approval of the minutes of Deacons Meeting of October 27, 2020; a motion from the Personnel Committee to approve proposed changes to the Personnel Policy; a motion from the Personnel Committee to approve an updated job description for the position of Administrative Assistant; a motion from the Personnel Committee to approve an updated job description for the Sound Technician; and a motion from the Personnel Committee to provide a \$2,000 bonus to David McConnell-Booher for the extra tasks that he has performed in the last 6 months of 2020, to be paid in the last pay period of the year.

The 2021 Budget came up for final review and adjustments.

It was **moved**, **seconded** and **passed** to reduce the line item under WORSHIP for Pulpit Supply by \$400 to \$1,000.

It was moved, seconded and passed to adopt the 2021 Budget as presented and amended.

It was **moved**, **seconded** and **passed** to amend the 2020 Budget by not moving funds into the Sabbatical Fund for 2020.

The Session has been in negotiations with an EPC Teaching Elder to serve as a Transitional Pastor for FPC.

The Personnel Committee presented a proposed contract and moved that it be approved. It was **moved**, and **passed** approve the contract.

It was **moved**, **seconded** and **passed** to notify the congregation via email and in services of activity being accomplished by Pastor Search Committee and Transitional Pastor search.

It was **moved**, **seconded** and **passed** to call a Congregational Meeting for the purpose of electing to the Pastor Search Committee on January 3, 2021 after the morning church service.

Session Ministry Teams presented written and verbal reports.

It was **moved**, **seconded** and **passed** to have Ruling Elder Keith Nore serve as liaison to the Nominating Committee.

A written report on the finances of FPC was prepared by the Church Treasurer, Christy Repasky.

Devotions for the January Session Meeting will be provided by Ruling Elder Jim Williams.

Elders spent time in prayer. After making prayer requests known, elders prayed for one another and for First Presbyterian, and the meeting was adjourned, in prayer by David McConnell-Booher.

The next Stated Session Meeting will be held on January 19, 2020 at 6:00 pm via Video Conference.
